

Smalls Acts That Give Back – Hometown Hero Campaign

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. **Eligibility:** This Campaign is open only to those who have been nominated and who are 18 years of age or older as of the date of entry. **Nominees must live in the Merrimack Valley of Massachusetts or New Hampshire. Nominator must indicate what small act the Nominee performed that had a big impact on the Nominator or the community. Nominee cannot have been recognized locally or nationally for the good deed. Nominee cannot be a paid employee/member/contractor of a company associated with the good deed.** The Campaign is void where prohibited by law. Employees of Jeanne D’Arc Credit Union and immediate family members and/or those living in the same household as Employees are not eligible to participate in the Campaign. 3. **Campaign Period:** Entries will be accepted via email, mail or in branch beginning at 8:00AM on Monday, April 29, 2019 to 12:00 NOON on Friday, May 24, 2019.

4. **How to Enter:** The Campaign must be entered by submitting a nomination using the online form. These forms can be found on LoveJDCU.com, in branch, or available through mail upon request. The entry must fulfill all Campaign requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of Jeanne D’Arc Credit Union. Forms must be completed in entirety to qualify.

5. **Prizes:** Four winners will be chosen over the course of the campaign. The Winner(s) of the Campaign (the “Winner”) will receive \$250. These winnings may be presented in the form of a deposit into an account at Jeanne D’Arc Credit Union or by check. Any and all prize-related expenses, including without limitation any and all federal, state, and/or local taxes, shall be the sole responsibility of Winner. Acceptance of prize constitutes permission for Jeanne D’Arc Credit Union to use Winner’s name, likeness, and entry for purposes of advertising and trade without further compensation, unless prohibited by law. Winner(s) will be required to sign a “Talent Release Form” upon notification as Winner.

6. **Odds:** The odds of winning depend on the number of eligible nominations received.

7. **Winner Selection and Notification:** Winner(s) will be selected by an internal judging panel at Jeanne D’Arc Credit Union. One Winner will be chosen on each of the following dates: Friday, May 3, 2019; Friday, May 10, 2019; Friday, May 17, 2019; and Friday, May 24, 2019 by 2:00 PM EST and will be notified by phone or email within five (5) days following selection of Winner. Jeanne D’Arc Credit Union shall have no liability for Winner’s failure to receive notices due to spam, junk e-mail or other security settings or for Winner’s provision of incorrect or otherwise non-functioning contact information. If Winner cannot be contacted, is ineligible, fails to claim the prize within 5 days from the time award notification was sent, or fails to timely return a completed and executed declaration and release as required, the prize may be forfeited and an alternate Winner selected. Receipt by Winner of the prize offered in this Campaign is conditioned upon compliance with any and all federal, state, and local laws and regulations. Terms & Conditions: Jeanne D’Arc Credit Union reserves the right, in its sole discretion, to cancel, terminate, modify or suspend the Campaign should virus, bug, non-authorized human intervention, fraud, or other cause beyond Jeanne D’Arc Credit Union’s control corrupt or affect the administration, security, fairness, or proper conduct of the Campaign. In such case, Jeanne D’Arc Credit Union may select the Winner from all eligible entries received prior to the action taken by Jeanne D’Arc Credit Union. Jeanne D’Arc Credit Union reserves the right, in its sole discretion, to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the Campaign or website or violates these Terms & Conditions.

10.
